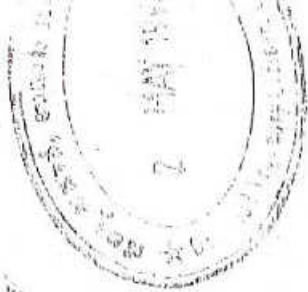

 - f) To support and promote the advancement of educational activities in all its branches, such as kinder-garten, Primary and High Schools, Colleges, leading upto and

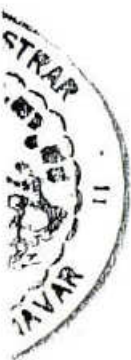

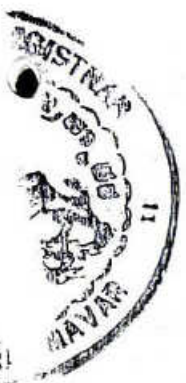

- c) To invest the Trust funds from time to time in such securities and in such manner as them deem fit, to alter or vary the investments from time to time to realise the investments, to acquire or to sell-securities, debentures, stock and shares without contravening clause 20 herein.
- d) To acquire, on lease, by purchase or otherwise, to sell, mortgage, to lease out or transfer in any other manner properties movable and immovable, to construct buildings and other improvements for the purpose of the Trust and to manage and deal with properties, movable or immovable and all other assets of the Trust and to pledge them to raise funds to repay loans or otherwise and to deal generally with the assets for the purpose of the Trust.
- e) To receive, collect or realise or cause collection or realisation of all interests, dividends bonus

- f) To execute, or negotiate all the necessary papers and documents (whether negotiable or non-negotiable), to receive moneys and other assets and to grant receipts and discharges.
- g) To represent the Trust in all Courts (Original or Appellate) or before any authorities and departments of Government, Semi Government or local Authority.
- h) To sign and verify all pleadings, memoranda of appeal, petitions and applications of all kinds, to compromise or refer to arbitration whole or any part of the claim by or against the Trust, to engage lawyers and to take all necessary steps.
- i) To borrow for the purposes of the Trust on the personal credit of the Trust or without charge and responsibility upon the assets of the Trust.
- j) To meet all the necessary expenses incurred or to be incurred in connection with the creation and execution of this Trust.

k) To open and maintain accounts of any nature in any Bank of their choice and to authorise operations of

- 1) To do all other acts, deeds, matters and things which they deem necessary for carrying out the objects of this Trust or its Administration.
- m) To negotiate and enter into any agreements with any Government, University Municipality, Mandal Panchayat or any other public or private authority, which may seem conducive or beneficial to any of the objects of the Trust, or be intended to enhance, improve or render more efficient the property, work or activity of the Trust.
- 9) All the Trustees other than Sri H. Nagaraja Shetty and Swapna N. Shetty shall be the Trustees for 5 years and Sri H. Nagaraja Shetty and Swapna N. Shetty shall be the Trustees for life. In case of any vacancy amongst the life Trustees/Trustees occasioned by death, resignation or incapacity or otherwise, the remaining Trustees shall appoint another Trustee to fill up the vacancy. If a Trustee is not appointed by the remaining Trustees within two months from the date of vacancy, the Author of the Trust shall be

Trustees to assist and advise the Trust.

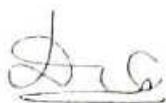

11) The President of the Board of Trustees shall at all time to be competent to call a meeting of the Board of Trustees suo moto.

11. All or any of the power vested in or exercisable by the Trustees as per this Deed of Trust shall be capable of being performed or exercised by a majority of the Trustees, and any action or decision of such majority shall, subject to the provision contained in the para (10) supra, be as valid and effective as it would have been if done by all the Trustees. If, However, in the opinion of the Secretary, the calling of the meeting of the Trustees is impracticable for any reason, a resolution passed by the unanimous consent of the Trustees by circulation of papers shall be as valid and effective as if passed by the majority of the Trustees at a duly convened meeting.

and the Trustees shall not be entitled to draw any remuneration for carrying out their duties but shall be entitled to be paid their actual travelling expenses and other incidental charges incurred by them for attending the meetings of the Board. The Board of Trustees shall meet from time to time (but not later than three months from the meeting held last) as and when necessary to transact business and for considering the betterment of the Trust and its assets. The quorum for the meeting of the Board of Trustees other than a meeting convened by two Trustees under Para 10(1) supra, shall be three.

The President of the meeting shall have a casting vote in case of equality of votes. Notice of all meetings of the Board either by ordinary post or otherwise shall be given to all the Trustees and for this purpose the posting of a communication addressed to the Trustees shall be deemed to be sufficient notice.

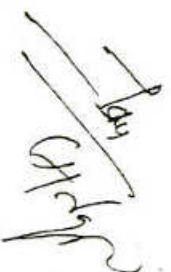

Once at 31st March of every financial year, the accounts, of the Trust shall be examined and the correctness of the accounts and the balance sheet ascertained by a Chartered Accountant accounted by the Trustees and countersigned by the Treasurer and the President of the Board of Trustees.

14. The Trustees shall have power from time to time to make and alter such rules and regulations with regard to the conduct of the business and all matters in respect of any power or duty hereby vested in them as they may think proper. The Board of Trustees, if they so choose and for the benefit of the Trust, may delegate by means of a resolution in writing any or all of their powers to anyone or more of them or any other person or persons for such time and purpose as they deem fit.

15. The Trustees shall be at liberty to add or to alter or abrogate any of the provisions of the Trust in manner not inconsistent with the objects of the Trust.

17. The Trustees shall be respectively chargeable only for such moneys or securities as they shall respectively actually receive notwithstanding their respectively signing any receipt for the same of confirmity and shall be answerable and accountable only for their own acts, receipts, neglects or defaults and not for those of each other nor for any banker, broker, auctioneer or other persons with whom or into whose hands any trust monies or securities may be deposited or come or for insufficiency in title or deficiency in value of any investments nor for any other loss unless the same shall happen through their own willful default respectively.

18. The Trustees may reimburse themselves or pay and discharge out of the said Trust properties all expenses incurred in or for the execution of the Trust

20. The funds of the Trust shall be invested in any of the modes specified under the provisions of Section 13(1)(d) read with Section 11(5) of the Income Tax Act, 1961 and the Rules made thereunder as amended from time to time.

21. This is public registered Trust. The property of the Trust shall in no case revert to the Author of the Trust or its descendants or to any other persons provided that in the event of dissolution or winding up of the Trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed among the Trustees, but the same shall be transferred to another charitable trust, society, association or
